# **Wood Floor Deep Clean**

#### 1. Product Description

Intensive cleaner for oiled and lacquered wood and cork floors designed to remove wax residues and polishes. Flammable.

#### 2. Areas of Application

Sealed as well as oiled and waxed wood and cork floors.

#### 3. Method of Application

Remove coarse dirt with a sweeping brush or vacuum cleaner. When treating sealed floors, apply Wood Floor Deep Clean to the floor surface using a wide-headed wiper mop. Avoid the formation of pools. Allow to stand for approx. 10 minutes. Loosen the protective film using the Padmaster System with a white pad.

For larger areas, use a Monodisc SRP appliance instead of the Padmaster.

When working on oiled and waxed floors, dilute Wood Floor Deep Clean with water in a ratio of between 1:1 and 1:3 and begin the cleaning operation without allowing for a standing time, i.e., straight after application of the cleaning solution. Immediately take up all loosened dirt with an extractor appliance. In exceptional cases absorbent, dry wiper mops can be used. Then lightly wipe over the floor with clear water.

#### Attention:

Always treat the floor one section at a time. If at all possible, clean the floor in pairs, the first person loosening the protective film and the second person immediately taking up the loosened dirt. Sensitive surfaces (such as varnished furniture, skirting boards, doors) should not be sprayed with the cleaning agent. Check the surface of the floor for cracks in the varnish and open joints prior to commencing work. Cover metal surfaces and tape over settlement joints/transition profiles, etc. prior to performing the cleaning operation.

#### Note:

Wood and cork floors can absorb water in the area of seams and joints and then swelling can lead to a change of shape (particularly in case of floor coverings made of beech). Allowing the product to stand for a longer period of time on water-based lacquers can lead to the temporary formation of "milky" white marks. For this reason, the standing time should — without fail — be limited to a minimum and the floor never be left wet for prolonged periods of time.
